Denial of entry into U.S. of foreign nationals engaged in establishment or enforcement of forced abortion or sterilization policy, **8 USC § 1182e(a)\***

Continuous physical presence required to become US nationals, not citizens, at birth, § 308

Continuous physical presence required to preserve eligibility for naturalization, §§ 316(b), 317

Constructive residence for naturalization through service on certain US vessels, § 330

Continuous residence required for creating record of admission for permanent residence for certain aliens, § 249
